Institutions – Posting of Faculty for hostel rounds - reg.



The Faculty mentioned in the annexure are posted as Vigilance Officer in the Boys Hostel on the dates mentioned against them as a measure of Anti-Ragging, from 7.00 p.m. to 7.00 a.m. next day. The Faculty shall go over to the hostel by 7 p.m. on the day of postings and shall make entry in the register maintained by the Resident Warden, regarding the date, the name of the Faculty, designation and time of arrival, time of departure and put their signature with date. They should also make an entry regarding incident if any happened in the hostel during their posting time. They shall be available in the hostel till 7 a.m. next day. They can avail Post Duty Off on the next day in lieu of their Special duty done by them.

The Faculty posted as Vigilance Officer must attend duty on the dates specified without fail. If they are unable to attend the duty they should make themselves alternative arrangements with the consent of the Dean. **If any Faculty absent on the day of postings it will be viewed seriously and it will be treated as LOP.**

The Faculty who is posted as Senior Vigilance Officer for hostel duty shall make a visit at any time after 8.00 p.m. and shall make an entry regarding attendance of the Faculty on duty and they shall interact with the first year MBBS students regarding their comfortable stay. The above instructions should be followed scrupulously without fail.

If any untoward incident taking place in the hostel during the stay of the Vigilance Officer, it should be informed to the undersigned / Vice Principal at once so as to enable them to offer necessary advice and method of dealing the issue.


